Kingdom Parent/player/spectator Code of Conduct Agreement:

The Kingdom Sports Center owner, sports directors, and staff have adopted the following conduct policy towards spectators, coaches, league officials, parents, and players.

I. The following **WILL NOT BE TOLERATED** DURING Kingdom Sports Center Basketball events or on Kingdom Sports Center property and action **WILL BE TAKEN** for any of below mentioned behavior:

- A. Unsportsmanlike behavior, foul or abusive language from any staff member, coaches, players, parents, family members, and/or spectators during Kingdom Basketball practices, games, and/or Events on Kingdom Sports Center or other venues where Kingdom Basketball teams participate.
- B. Any inappropriate behavior that is considered detrimental to our children, participants, or this organization and its members during basketball functions or on Kingdom Sports Center Property.
- C. Fighting or other violent behavior from any person involved in any activity of Kingdom Basketball or on Kingdom Property.
- D. Spectators interference with officials of the on-going game which may not set a good example for players. This may include harassment, verbal language, and conversation related to game while game is in progress with the official. Officials include coaches, scorekeepers and referees.
- E. Spectators interference with league officials during any game will not be tolerated. This includes before, during and after any league game during any point of the season and post-season tournament. Interference includes verbal, physical, and another other kind of abusive view expressed by the spectator.
- F. Not following all rules of basketball program rules and related to code of conduct.
- G. Kingdom players are not allowed to play in another division and/or team without clearance from the Sports Director

II. Kingdom Sports Center reserves the right to ask any person(s) to remove themselves from a basketball event if Basketball director, member of our staff, and/or league coordinator involved in the current game agrees that the action warrants it.

- A. Kingdom reserves the right to call local authorities to have any individual removed from our facility if the individual will not peaceably leave the sports center.
- B. Any person will be held liable for damage or fines incurred during an event such as fines levied by referees, local authorities, or damage done to Kingdom Sports Center.

As a parent/guardian I also agree to the following:

I will encourage good sportsmanship by demonstrating positive support for all players, coaches, and officials at every game, or practice.

I will place the emotional and physical well-being of my child ahead of my personal desire to win.

I will support coaches and officials working with my child, in order to encourage a positive and enjoyable basketball experience for all.

I will remember that my child's game of basketball is for youth - not adults.

I will do my very best to make the sport of basketball fun for my child.

I will ask my child to treat other players, coaches, fans and officials with respect regardless of race, sex, creed or ability.

I will also treat with respect other players, coaches, fans and officials.

I will help my child enjoy the Kingdom Dynasty basketball experience by doing whatever I can to be a respectful fan.
